The combined strike and lockout members when he made the follow of more than forty thousand Akron rubber workers in the Firestone, Goodyear, Goodrich and General Tire and Rubber companies has driven home new lessons for the workers in this period. Chief among these lessons are the three major points which the RWL has long pointed out, namely; 1. The Truman administration moves rapidly to the right of the more demogogic regime of Franklin Roosevelt into a cruder, more open and vicious attack on the working class. 2. Dependency upon the policies and leadership of "left" demagogues like Walter Reuther in the UAW-CIO and Wheeler and Watson in the URW-CIO has the same end result for the rank and file as does dependency upon the policy and leadership of the R. J. Thomases and the Dalrymples - defeats for the workers through betrayal by their leaders. 3. Only an active and militant Rank and File leadership organized from among the workers in the shops and leading the workers struggles against the Truman administration war policies in every governmental board or agency and against the strategy of betrayal of their own leadership in the open reformist camp and the "left" camp of the "radical" demagogues, can assure victory

On July 5th the U.S. Navy, acting under an executive order signed by President Truman, moved into the plants of the Goodyear Tire and Rubber company at Akron and "took over." The Naval officer in charge of this operation was one Captain Clark who was never a military man in the navy for purpose of battle but a former big business executive in civil life until the outbreak of the war, and who was assigned to the navy's strike-breaking organization known as the division of the special executive branch of the Navy for the settlement of labor disputes.

Captain Clark's first actions after seizure of the struck Goodyear plants was to prohibit picketing; order the strikers back to work un-Oder threat of loss of gas rationing allowances, withdrawal of draft de-Afferment status, refusal of job re-feral cards, loss of unpaid two years' vacation pay and two years' Opremium pay already earned under an expired contract, etc.; he retained and pledged full cooperation with the same plant management existing before and during the strike; and he issued official statements saying that the navy would deal with management and the individworker but refused ual recogniz Mr. Wheeler, president of Local No. for an equal time. ing statements on the plant seizure: We are now working for Uncle Sam. We will not defy the president of the United States. We will go back to work while our grievances are being processed. I will insist that these be settled forthwith. We union officers intend to have all grievances settled. You will get the justice you deserve. We will demand that we get back our night shift bonuses and vacation pay and we will also ask for a union shop. We will now go back to work. We have lost nothing and the union officers will continue to see that you lese nothing." It was unfortunate that the militant rank and file had failed to organize a leadership prior to this time as such a leadership would have been able to take over the meeting of the local then and there and continued the strike.

tant Negro worker of Chicago and active member of the organized working class movement is now in the hands of the U.S. Army at Ft. Sheridan, Illinois. His family and friends do not know whether he is there as a member of the armed forces or as a prisoner of the military police as we go to press. And thereby hangs a tale of no little portent to the workers.

Allan Willis is over twenty-nine years of age - over the usual age now inducted into the armed forces. He has been under the care of various reliable physicians for serious and complicated allergies for a period dating back years prior to any selective service act. He has lived at the same address for several years and worked at the same place fully met all legal requirements in and all instructions from his local draft board. But Willis is a known fighter for the rights and interests of the workers and the oppressed minorities - and Willis is a Negro. So the usual procedure in the process of induction was not followed in the case of Allan Willis. In their growing fear of the working class and their determination to destroy the workers organizations and leadership, the bosses of Chicago en listed the aid of the local draft board, the Federal Bureau of In-

July 15, 1945-Allan Willis, mili-|shall and the army military police in a dictatorial and gestapo-like violation of usual procedure and constitutional guarantees. They delivered him under arrest to the military police without benefit of trial or recourse to any of his legal rights as a civilian. Here are the facts:

> On or about the second of this July, Willis received a letter from the Chicago office of the FBI at his usual address stating that their office had been informed that he. Willis, had failed to appear before his local draft board for induction and requesting Willis to appear at their office. Willis went voluntarily and at once to the FBI where he was informed that his local board had sent him a letter to appear some weeks before. Willis told the FBI that he had received no such letter and would have appeared before the board in the event he had received such letter. He pointed out to the FBI the fact that he had, on several previous occasions, received letters from his board at the same address and had in every instance carried out their instructions. He pointed out that he had been at home every day since the alleged letter was mailed and had continued in his usual and known place out that he was before the FBI in response to an ordinary letter voluntarily and would go to the draft board at once. Protest in Milan In Milan last month the working class went out on a general strike unemolov in protest against th ment. They are only earning approximately 15% of what they earned previously, and they militantly demanded a guarantee of 75% of their base weekly pay. This guarantee was in effect during Nazi occupation. But under the "democratic" benevolency of the Allies their wages are at a starvation level. The new Parri government in Italy

is only another stopgap, another tool for the big imperialist powers. The fact that "socialist" Nenni and Stalinist Togliatti are members of this government is a treacherous circumstance that the workers of Italy will long remember. Even while the new Parri government was being sworn into office crowds before the AMG headquarters in Milan were shouting for Bread and Work. The same thing happened in Turin and a dozen other large cities. In two towns the crowds broke into the jails and killed thirty fascists.

The people of Italy are as vicious against the hunger of their British and American "liberators" as they were against the Nazi "liberators," and they are undoubtedly preparing for similar action, strikes, guerrilla struggles and Revolution.

The austere Time magazine points out that "U.S. and British policy had never seemed more out of touch with popular feeling." The people are singing: "And from AMGOT deliver us, O Lord!"

British Iron Hand

The same picture is being repeated throughout Europe. Production has not yet really started up in France or Belgium or Holland. In the Low Countries even the pro-Allied ministers can not breathe without British permission. British of employment. He also pointed forces are treating these nations as conquered territories, for all practical purposes. take this lying down. The workers are disregarding the no-strike pledge (which was forced on them by the labor fakers) and are taking to the picket lines in increasing numbers. The Labor Dept. Conciliation Service reported that the daily average of strikes had risen from 20 before V-E Day to about 40. In St. Louis 2700 workers were out on strike in a fuse plant, the rubber plants in Akron had 16,700 workers striking, 10,000 troops were sent to Chicago to take over the truck lines when the drivers went out on strike, etc. To mention the workers on strike all over the country would be a long, tedious report. The statistics aren't as important as the fact that strike sentiment is spreading like wildfire, sweeping the entire country in ever-increasing strength and momentum. These strike actions are an attempt on the part of the workers to fight against the obvious danger of the lowering of their 'living standards thru cutbacks and growing unemployment.

The Labor Dept. Conciliation Service was perplexed and perturbed over this situation and after an investigation came out with these reasons for the strikes: 1. Paychecks arrived late. 2. Lunchtime checker games prohibited. 3. War nerves. 4 Hot weather

The Double Standard

It must have taken a tremendous amount of research and study to produce such answers that would evade the real issues so well! The resentment of the working class is not over the superfluous reasons of checker games being prohibited. The resentment of the worker has a real and well-founded basis. He resents the shutting down of plants and his being thrown out of work. He resents the reductions in pay that deprive him a living wage. He resents the fact that congress is

Murder Machine



Marxist slogan "workers of the world unite!" running thru its program like a steel cable, fortifying international working class solidarity, can never find itself playing the role of stool-pigeon or apologist for the police of the enemy class.

The working class has becos bitterly case hardened to the Stalinist abandonment of the principle of working class solidarity, but, when a section of the Trotskyite International plays a role similar to that of the Stalinists that is news - bad news. It reveals the organizational deterioration that accompanies its political degeneration.

The Revolutionary Communist Party of England, a Trotskyite section, (despite its radical name) has as its main programmatic plank "Labor to Power" - thru election of the decrepit Labor Party.

The Leninist League of Great Britain, sister group of the Revolutionary Workers League, has as its main programmatic plank the establishment of a Soviet Great Britain - thru the overthrow of the capitalist system.

Both organizations are small; the members know one another personally and politically. Personal contact and polemicizing are an everyday occurrence. In the face of this what follows is even more significant.

Two comrades of the Leninist League were recently arrested by the Special Branch of Scotland Yard. They were charged with "identity card offences" and sentenced to prison terms. Upon release, in discussion with members of the RCP. they learned that the RCP top committees KNEW TWO WEEKS IN ADVANCE THAT THEIR ARREST WAS IMMINENT!

How does it happen that a "Revolutionary Communist Party" knew in advance what Scotland Yard was contemplating? How does it happen that they did not send a message to warn these fellow workers of the plans of the police? How does it happen that TODAY they defend and justify their actions?

THE FACTS OF THE CASE

Copies of the correspondence and statements involved have been sent to the "Fighting Worker" and we quote from sections of them. We are using initials instead of names for obvious reasons.

The Leninist League, when it heard that the RCP knew and kept silent about the plans of Scotland Yard, sent a formal letter asking for an explanation. Here is an excerpt from the reply:

"To the Secretary of the Leninist League: In reply to your letter . . . A) certain of our comrades were informed via A.T., your one time friend, that he had informed the police as to certain alleged CRIM-INAL activities on your part . . blackmarket activities,

C) since this information was of a criminal character and not an attack against your political programme, the question of "Solidarity between working class political groupings" did not arise . .

The Leninist League made further investigations into this peculiar relationship of a working class organization with Scotland Yard and rot a statement of fact from the individual who acted as stool-pigeon which revealed even further implications. The statement follows in its entirety:

"Due to a personal guarrel with E.R. some five months ago I informed the police that he was living under an assumed name. As his use of a name other than his own was

An organization which has the ICAL ACTIVITIES, I notified the Special Branch at New Scotland Yard. I wish to emphasise this point as it has been said that I gave information regarding "blackmar-keting activities, etc." This is not true.

> "A fortnight elapsed before E.R. and his colleague D.L. were acrested, but on the day I gave the information to the police I also informed a member of the RCP., A.C., of what I was doing. He suggested that I should work on behalf of that party and obtain information from the police of their activities within the RCP. To this I agreed. A special bureau was set up in the RCP composed of M.L., H.A., and A.C., under whose instructions I worked.

"I now regret my actions and the harm done and my purpose in mak-ing this statement is to help in clarifying the situation." A.T.

creating hatred and a break-down in the economy.

Unemployment, strikes, and a gigantic black market - such is the general picture in France.

A reminiscent play is being enacted throughout Europe. The masses are chafing at the bit, moving rapidly to the left. There are practically no countries in Western Europe in which the Socialists and Stalinists do not represent a majority of the population. As the pendulum swings left the social reformists are being pushed to the head of the working class in order to behead their class struggle activity and channelize things into safe capitalist - POPULAR FRONT - channels.

In Italy, in France, in Holland, in Belgium, the reformists control or can control the government at any time. But the end result of this policy is quite evident in Greece. There Popular Frontism dominated by the Stalinists in the ELAS demoralized the masses just as it is doing in the other nations. And now, despite the "truce" in the civil war, there have been at least 4,100 violations of the agreement ELAS. Loadore of the FLAS being picked up and executed.

Shift to Left

The tenor of the masses in continental Europe - and spreading to England and Canada and the U. S. - is LEFTWARD. The war in Europe is far from over. On the contrary it is merely being converted into a gigantic civil war of the working class against capitalism. The only distinction with the past is that instead of the Nazi Counter-Revolution, the masses now face the naked dictatorship and bayonets of the Allies. In some respects the latter rule is even worse.

Out of the hunger and tyranny of CONSEQUENCE OF HIS POLIT- Europe under the Allies can only IAN REVOLUTION!

come a more vicious and bruta Fascism. And it will come as it came in 1933 and 1922, with the permission and aid of the American and British capitalists_ Churchill praised Mussolini to the skies at one time. American financiers helped both him and Hitler to power. The Allies are again waiting to put new Fascists into power - they are merely biding their time until the social reformists can demoralize and confuse and disunite the masses sufficiently for the 1945 Hitlers and Mussolinis to take over.

This war was not fought to exterminate Fascism. Any one looking at Europe today can note that with a single glance. On the contrary, American and British capitalism will never rest still until they smash the working class organizations in Europe and establish their own brand of Fascism, or at least military dictatorship of the Voulgaris type.

ONLY THE PROLETARIAN REVOLUTION CAN DEFEAT FASCISM! To have faith in bourgeois democracy today means to prepare the world for more wars and more counter-revolution, more fascist tyranny. July 10, 1945. Chicago; city of lake ports, railroads, factories, department stores, steel, stockyards and stock exchanges reflects the class strife that is becoming more and more evident throughout the country. A brief digest of some of the events transpiring here in this city of some four and onehalf millions population gives also a kalaedoscopic picture of the class relations in every industrial area.

EDITOR'S NOTE-Since this was written the pressmen were ordered back to work by the union president, and the strike has been broken.

At the Donnelly Printing Co., (one of the largest in the world, where Life and Time are printed for Henry Luce) there has been a Union organizing campaign since 1906. The Union has been refused recognition in the past because the original owner left a clause in his will which states his heirs shall lose the plant if it becomes recognized as a Union Shop! Today over 600 Donnelly workers are out on strike fighting for the closed shop and Union conditions. There is a militant mass picket line and every day (despite the pleas of the WLB), fewer and fewer scabs go to work and more and more join the line. The tactic of picketing the homes of the scabs has undoubtedly brought results.

The Donnelly owned plant in San Francisco, (which is a stronger Union town) is 100% organized and recognized by the company and still the heirs haven't had to forfeit their property!

SELL-OUTS vs. STRIKE SOLIDARITY

The nationally infamous Montgomery Ward case is still wending its way thru the courts. The workers went on strike for Union recognition and contract renewal, and in eventual hope of better conditions and wages. Sewell Avery with the powerful aid of the Chicago Tribune has kept his case simmering. The notorious local courts came to the rescue by deciding that Montgomery Wards are not "producers" but merely "distributors" and that therefore the Army had no right to run the company even at a good profit for the owners. The courts also attempted. without success, to issue an injunction restraining the Union paper from being published prior to being censored by the court because they anticipated that "it won't tell the workers the truth . . . about the relations of the company to the employees . . .

The Montgomery Ward strikers, despite their fight on the picket line, lost out in the deal made between the Union officials, the WLB representatives and the military instrument of the government . . . the army.

The past period has witnessed thousands of strikes here, from the smallest plants to the enormous Pullman Standard and Republic Steel corporations. The gigantic Illinois-Carnegie plant alone has struck over 200 times since the war began. Demands ranging from improved sanitary facilities to full Union recognition with closed shop have been presented. Most of these strikes have been sporadic and departmental. Today the workers are functioning more cohesively. The more recent strikes have indicated the tendency toward PLANT-WIDE ACTION, after cool deliberation and with efforts toward planning TO WIN BACK ON THE PICKET LINE WHAT THEY LOST THRU CONFIDENCE IN THE LABOR FAKERS AND NEGOTIATIONS WITH THE WAR LABOR BOARD!

RACKETS OPEN AND CONCEALED

Another aspect of life in the big city of the middle west is the tree mendous traffic in black market merchandise and above ceiling prices. Everything from tires, chickens, cigarettes, beef roast and to men's shorts can be purchased if you have the price. Despite the fact that this is the largest meat packing center in the world there has been a meat shortage for the working class beyond parallel in this country (excepting the days of the depression when meat was a luxury too expensive for the average worker's paycheck). The black market flourishes hand in hand with the corrupt courts and police system. Chicken, for example was being openly sold at \$1 a pound still kicking, popular brand cigarettes for 50c a package.

Housing, one of the sorest spots all over the country is a particularly acute racket here. OPA ceilings are flagrantly violated (a new water faucet is installed and the rent goes up). Apartments are to be found providing you also buy the furniture that is in it . . . at a very fancy price! The restrictive covenant, which keeps Negroes, in particular, and Chinese, Mexican, Japanese and Jews from living in a certain area by written agreement of the property owners is upheld by the courts. This has created shameful overcrowded ghettoes and uum areas where the property is permitted to deteriorate but the rents average 15% higher than in non-restricted areas.

Sunday, June 24th, hundreds of Negroes and a handful of white people paraded in protest against the restricted covenant. The daily press gave unsympathetic reports, but the fact that people are again coming OUT INTO THE STREETS AND MAKING THEIR DEMANDS OPEN-LY is good. Bigger demonstrations which will lead, not to a ghetto park, but to the City Hall would be more effective. The largest property owner in the Negro ghetto is none other than the much touted "liberal" University of Chicago!

Over the war years there is decidedly visible a growing unity of the working class of Chicago. The hard depression years left a lesson that all the influence of the boss press and social-patriotic blather of the labor fakers has not been able to wipe out.

The war time restrictions, taxes, exploitation and alibies are also leaving their mark. The industrial worker must soon draw the conclusion that the system of production for profit is responsible for his constant enslavement . . . When that conclusion is realized the next step will be that of mighty upheavals to burst the chains that bind them.

BRITISH ELECTIONS EXPOSED

An Open Letter to All British Workers On the Sham General Election.

June, 1945. You are being asked to return a new Government from one of the two main parties, the Labour Party or the Tories. Both parties are determined to maintain capitalism. This they screen by lavish, lying promises of full employment, housing, pensions, independence for India and the Colonies and the abolition of imperialist wars. Although capitalism has exposed its inability to solve any social crisis, both parties have the audacity to ask for your mandate to continue the capitalist system. The main issue before the whole world to fay is whether or not capitalism should be abolished.

No party, barring one small "parliamentary reform" socialist party - certainly not the two main parties - has asked for a vote on this issue. Therefore the General Election is a SHAM. No matter who gets in, the workers will be swindled.

The Tories are completely identified with the defence of the privileges of "Big Business." The Labour Party, who in their 1929-31 government introduced such anti-working class legislation as the infamous "Means Test," ask to be returned on a programme of "Public Control." This is a deliberate trick to deceive the workers into believing that it means the overthrow of capitalism and the introduction of socialism. A Labour Government; because of its pseudoreformist character, will inevitably carry out the dictates of "Big Business" as it did before, and, as its power to deceive grows less, it will conspire with the representatives of "Big Business" to pave the way for rule by terrorism -FASCISM.

We, a comparatively new working class organisation, cannot yet put candidates in the field. The only candidates we can endorse are workers who are free from the discipline of treacherous parties and who fully serve their class. But we must issue a warning! SOCIALISM will not be achieved through parliament but through WORKERS COUNCILS OF ACTION in the factories, mines, shipyards etc., under the leadership of the workers own REVOLUTIONARY PARTY.

The Trotskyites use some demagogic words about "support with criticism" but the end achieved is all the same, derailing of the workers energies from independent working class action and independent revolutionary politics into reformist channels.

Past labor history has proven that the Capitalist Class only exceeds to the demands of the workers when, thru INDE-PENDENT WORKING CLASS ACTION, they THREATEN the power and economy of the ruling class. Then only concessions are granted.

These Misleaders of Labor attempt to hide the real nature of the existing decaying economy, by omitting the obvious tenant that Capitalism can have no further periods of expansion without Imperialist Expansion and Imperialist Exploitation. The immediate cause of the strike of 7,000 shipyard workers in Bethlehem's Steel Hoboken ship repair yard is a protest over a wage cut handed to the riveters in spite of an existing CIO wage agreement. The united action of the workers comes as a result of the brazen union smashing campaign of the Bethlehem Steel Co. For the past few months there have been numerous departmental stoppages, each time brought under control by the local CIO laber fakers but seldom settling any grievances. The present strike is a result of an accumulation of unsettled grievances and the company's complete disregard for union recognition except for the check-

making plans for the capitalists to continue making profits (Truman gave sanction to congress to present big business with \$5,700,000,000 in the next two years in refunds and reduced taxes) while no plans are made for his welfare or his family's.

He resents the fact that the big capitalists like E. I. du Pont de Nemours Co. Inc. had been indicted nine times in the last three years on anti-trust charges and yet was acquitted recently despite the damning evidence of their forming a world wide cartel to control production, sale and price of certain commodities. He resents the fact that virtually no ceiling was placed on the profits or the salaries of big business men (857 leading manufacturing companies made a net profit after taxes of \$2,763,171,176 in 1944) while he has to fight like hell because of the "Little Steal" straight jacket, to get a \$.05 raise and then by the time the WLB gets around to approving the raise, the price of living has gone up and he needs another \$.05 in order to try to keep his family fed. These are the real reasons for the strikes -THE ECONOMIC INSTABILITY OF THE WORKING CLASS UN-DER CAPITALISM.

Sharpening the Axe

Though the boss class is making no preparation for the welfare of the unemployed workers, it is making sure that its weapons against the workers - its strike breaking methods - are in good condition. For example, we find that the Detroit News tells of a "demonstration of riot drill tactics by combined forces of Detroit Police, Michigan State Troops and 728th Military Police Battalion of Camp River Rouge was. termed 90% effective." We find the army and navy being used more frequently as direct strike-breakers as was the case during the Chicago truck strike. And we also find the police using tear gas to break up a clash between the pickets and the scabs at the Indiana Brass Co. in Elkhart, Indiana. They proved that they were fully informed on his activities in these fields to the letter. That his activities were perfectly legal was established then and there altho the old red herring was used by the FBI agents during the questioning. Willis was advised to return home and await developments from his draft board. This he did.

Several days after the above events Willis was arrested during working hours at his regular place of employment on a warrant issued by the U.S. Marshall charging draft evasion. He was taken under arrest to the marshall's office where the above facts were established, examination waived, bond set and Willis released under bond with instruction to deliver himself into the marshall's custody on the morning of Friday, the thirteenth of July. He was to be delivered from the marshall's custody into the custory of the U.S. Army at his local draft board. This Willis did under protest. That is the last his family or friends has seen of him to this date. It is assumed that he is now at Ft. Sheridan but his status there is unknown.

All this on the unsupported word of someone on the local draft board that the ysent a usual letter - ordinary first class mail - to Willis and he had failed to respond. No attempt was made to prove that this ordinary letter had been written or received.

Under the constitution the benefit of the doubt rests with accused and the burden of proof rests with the state. The obvious fact that the rubber barons, in keeping with the other big business interests, were demanding and getting their "rights" by the billions and conceding no obligations whatsoever plotely overlooked by Mr. Taylor.
