FEVER FROM RICH TO **WORKERS' FAMILIES**

Old Story by Carlyle Dramatized Again in Real Chicago Life

FROM MANSION TO SWEAT SHOP AND BACK AGAIN

The Producer's Child Dies for Lack of Care-The Schemer's Child Lives Through the Disease With Aid of Money

Carlyle once told the story of a poor woman of Edinburg who applied for relief to a score of charitable associations on the ground of her common sisterhood, but was rejected.

She then took a fever, died, and in her death proved her sisterhood by infecting a city with the disease.

The latest development of the scarlet) fever epidemic in this city furnishes another chapter to this old

The whole story of the course of this scourge among the children of Chicago is an epitome of capitalism.

Starting in the fiendish greed for profits on the part of a milk company, it was perpetuated first by the same greed for profits and class terrorism over the daily press, that suppressed the facts that might have

saved lives until they were forced to action by the Daily Socialist.

The epidemic was next maintained through the criminal subserviency of Dr. Whalen and the Chicago Health Department to the private interests that would have been struck by an effective enforcement of the law.

From Rich to Poor Now another chapter has been added.

The first ravages of the favor were confined almost exclusively to the wealthier portions of the city and suburbs because it chanced that these

were the sections served by the milk company that introduced the disease. Now the disease has spread to the workers. Here it is no longer met with the skill and care that has made its ravages less terrible among the rich.

The worker's child can have no trained nurse hovering above its bed; no highly skilled specialist's care, none of the elaborate precautions as to dietary and nursing that mean the difference between life and death to

The most striking proof of what this means is seen in the sudden rise of the death rate from the fever pa-tients which the statistics reveal the moment the scourge passes from the suburb to the crowded tenement. Nor is even this the end of the

story.

Just as the brotherhood of the race was proved by Carlyle's widow, and as it was proven again as the spread to the of the fever from the mansion to the tenement, so now it is being proven once more by a return from the slum to the boulevard.

The poor cannot halt in their toil because death and disease look in at the door. They have no time for leisure even with such grim visitors.

Products but Not Germs

But the poor do not enjoy their own products. The worker has no control over the results of his toil. So long as these results are goods, the capitalist has no complaint. But just now the laborer in the sweat-shop is sending along with his finished product the germs of the deadly pestilence that has laid its hand upon aim.

So it is that the fever is rushing

So it is that the fever is rushing back from the tenement to the palace, and there ecomes a sudden cry for protection. This cry does not come from the workers. They seem too crushed to cry out.

But from the factory inspector comes the statement that sweatshop products are spreading the disease into all quarters of the city.

At once there arises a demand for

products are spreading the disease into all quarters of the city.

At once there arises a demand for stricter inspection. A city council that sat supinely quiet while great milk companies were bringing the disease here, that had nothing to say when Dr. Whalen refused to take any action to protect the spread ct the epidemic from the homes of the rich to those of the poor, now is suddenly stung into action by the fact that the existence of the disease among the workers threatens the lives of the whole exploiting class. Now the city council is rushing through emergency appropriations to provide for adequate inspection, is threatening an investigation of the negligent, if not work, health department, and is granting money for the employment of nurses.

Fever Increases

Today touched the highest point that any epidemic of scarlet fever has ever reached in Chicago, 407 cases being reported yesterday.

[Scripps-McRae Press Association.] Washington, Jan. 30. - President Roosevelt has reached a solution of the Japanese coolie problem, and will un-fold it to the members of the Califor-nia congressional delegation at the white house this evening. It is under-stood that the administration has effected an agreement with the Japanese ambassador, Viscount Aoki, whereby the laboring classes will be prevented by the Japanese authorities from tak-ing passage for the United States. It is not likely that the agreement with Japan will be announced officially. If it were the mikado's government would be attacked at home by the oppo-

would be attacked at home by the oppo sition party, which is sufficiently powerful to make the government a great deal of trouble.

The Japanese government cannot make a treaty with the United States along these lines, but can bring about the same result by exercising its power over the steamship-companies.

5 MEN, 1 WOMAN, HALF BOILED IN A SUGAR PLANT

Nineteen Students Give Skin to Save Life of Old Woman Worker-Fearful Conditions Awe Visitors

Madison, Wis., Jan 30.—After suffering for ten weeks' agony and torture, Mrs. Patrick O'Day died here yesterday. Mrs. O'Day, on Nov. I. was hadly scalded at the plant of the American Sugar Company's factory No. I.

The accident befell her while she was bringing lunch to her husband, who was employed there. Escaping steam prevented her seeing an open trap to a trench carrying along the waste hot water, and she stepped into it with one foot and was scalded to the hip. To save her life skin was grafted from nineteen students, but nothing availed.

Since her accident there have hap pened six similar ones at the sugar fac-tory. James Sparling, a foreman at the plant, fell into the same trap, and is now lighting for his life at the Madison City hospital. Five others have received sehospital. The United States Steel corporation report shows the net earnings for the quarter which ended on Dec. 31 last at \$41,744,964, as compared with \$38,-114,624 for the quarter which ended on Sept. 30, 1906, and \$35,278,688 in the last quarter of 1905.

The surplus, after the charges and preferred and common stock dividends for the quarter which ended on Dec. 31, 1906, are deducted, is \$18,-824,545, as compared with \$14,697,318 in the previous quarter and a surplus, after the charges and preferred stock dividend only were deducted, in the corresponding quarter of 1905 of \$16,-416,563.



SCORES OF WORKERS DIE FOR PROPERTY

In Europe and America Producers Invest Lives in Industry, but Their Heirs Will Get No Dividends

[Scripps-McRae Press Association.]

Favetteville, W. Va., Jan. 30 .- There is now no hope that any of the victims of the explosion in the Stuart mine yesterday afternoon are alive. The number of dead will probably reach 65, of whom about twenty are foreigners.

The great majority were Americans, married, with large families. Every effort is now being made to repair the machinery and refit the car shaft, so that rescuers may enter the ill-fated mine and bring out the dead.

An attempt was made to reach the bodies last night without avail. Three men were lowered into the shaft in an improvised basket. Before descending 60 feet two of them were overcome with foul air, and the third was barely able to give the signal to their comrades at the mouth of the shaft.

Further efforts were abandoned for the time, and the work of bratticing the shaft was commenced. This morning women and children are assembled near the shaft awaiting the bringing forth of their loved one, and the scene is heartrending.

The most horrible of the disasters, however, was an explosion in the Stuart mine, near Fayetteville, W. Va., occurring at 12.55 yesterday afternoom and which instantl, buried from 80 to 100 men who worked 500 feet below

The chances that any of the 107 men will be taken out of the mine alive are slim. It is believed that the terrific force of the explosion snuffed out their lives instantly.

The dievest is said to have been

The disaster is said to have been caused by the explosion of dust. It is believed, however, that an investigation will prove that there are more serious causes for the explosion than the mere bursting of dust. Proper ventilation is expensive and to save money for the coal barons these men died.

died.

Rescue work could be begun only after two hours had been spent in repairing the wreeked parts of the shafthouse. After three men descended 30 feet, they had to give up the at-

tempt.

It is almost certain now that it will take fully 48 hours before the men will be reached by the rescuers.

Many pathetic scenes were enacted about the mine today. Practically all the miners were Americans and were

married men. Their wives and children gathered about the mine and were meaning and crying for their rusbands and fathers.

They rushed from one to another, begging them to rescue the buried miners at once. When they were told that it will take two days before the miners would be reached many of the women were chast wild investment to commit suicide.

A powder explosion, which occurred at Johnston City, Ill, in the west side mine of the Johnston City and Big Muddy Coal Mining Company, instantly killed four men and injured seven others. A quantity of powder which had been sent down in the mine became ignited and exploded. Carelessness on the part of the managers in having no adequate supervision is given 28 the cause for the explosion.

Two workmen were instantly killed in an explosion in the pressroom of the Fontanet powder mill of the Dupout Company. Terre Hante, Ind., yesterday afternoon. In Germany

An official report issued by the German government places the number of those who were killed in the explosion of the government mine at Saarbrucken, as high as 148 men. Sixty-two corpses have already been brought out of the mine. Stories told by those rescued show a number of hair-breadth escapes.



Sham employment agencies that live campires on helpless working girls, their little savings and turning addiff with no return for their

y, are operating in every part of city victimizing young women.

Seven complaints against one employment agency, all by young girls who had paid registration fees and received nothing it return, have been taken up by Superintendent William H. Cruden of the Illianic fees employment bureau.

sing 1: return, have been taken up of the Illinois free employment bureau.

The agency complained of is Martin & Co. 171 Washington street. Marie Lauretta, 16 years old, 3152 Paulina street, is one of the girls who complained to the authorities.

She paid the \$2 registration fee on the promise that she would secure a position paying \$10 a week. She was sent to three different places, all of which claimed that they had no agreement to hire any one from Martin & Co., and that that they had never heard of them.

Ada Leventhal, 516 South, Wood street, paid the registration fee, and was told to go to Butler Bros. to address envelopes. She told the agent that she could not write fast enough. He replied,

could not write fast enough. He replied, "O, yes you can. Take the job, and we will get you another at the end of the

She did the work for a week and then returned to the agency only to find that it demanded her first week's wages and would do nothing to find her

These agencies prey upon working girls, who, in most cases, no not know the law and do not know how to go about prosecuting the agency if they are robbed of their money. Under the law as it exists at present all that the girl can do is to demand the refund of the money paid as fees.

AMERICAN SCIENTIST KNOCKS COLD STORAGE

Washington, D. C., Jan. 30.—(Special.)—Dr. Harry W. Wiley, Uncle Sam's food expert, has told the house committee on agriculture some start-ling facts concerning the dangers of cold storage, oyster shipments, and gelatin manufacture. The chief of the burcau of chemistry of the agricul-tural department informed the com-mittee, which has just made public its hearing on the agricultural ap-propriation bill, that milk and eggs are badly affected immediately upon being put in storage, that bulk oysters, if not "embalmed," frequently contain ptomaines, and that gelatin has n found to carry lockjaw germs. or. Wiley related the results ob-

br. Whey related the results of tained in two cold storage warehouses which are at his disposal in Washington, where he has conducted experiments with all sorts of foodstuffs. Milk and Eggs Quickly Deteriorate "Milk begins to deteriorate right away and so does cream," he said. "Eggs also begin to deteriorate immediately.

"Fruit is improved and sometimes continues to improve for three months. Meat improves up to about six or eight weeks. But after three months for meat you can see that it has reached the maximum. Then it begins to go down, I do not care how hard it is frozen.

When asked for a jurther explanation of the deterioration of meat frozen in cold storage. Dr. Wiley said:

"We find that meats do not taste

"We find that meats do not taste and smell as well. Every time the jury can pick that which has been kept more than three months.

"Take our quail. We have a quail a year old and a fresh quail cooked just alike at the same time. You can distinguish instantly between them—first by their looks, and then by smell and taste. Every time the jury can pick them out blindfolded."

Gelatin was denounced by Dr. Wiley, who said of ft:

ley, who said of it:

"It is made of the scrapings from hides that go into tanners' vats. These hides, which smell to heaven, are treated and trimmed. These trimmings are used to make gelatin. The marine hospital service found tetanus germs in gelatin."

DRUNKEN COSSACKS ARE KILLING GIRLS

Those Who Fear the Terrorists Are too Cruel Should. Read This Story of "Noble" Rule

Riga, Russia, Jan. 30.-Startling stories of brutality on the part of the authorities in treating girl and women political prisoners are being printed by the newspapers of this city.

A short time ago a 16-year-old girl, belonging to a prominent family in this city, was arrested, and after a few weeks imprisonment has been reported to have diec. An investigation into the causes of her death was begun by her relatives, and it was soon learned that the girl was flogged to death by drunken Cossacks after having been assaulted by them.

The papers give many more instances i floggings. They mention names of of floggings. They mention names of several middle-aged women arrested for

political reasons who were flogged. In every case they say the flogging was the result of the women refusing to submit to the brutal desires of the Cossacks, who are the sole masters over

Cossacks, who are the sole master over the prisoners.

The papers further say that the pres-ent chief of police of Riga, Baron Mel-ler-Zakomelsky, 'has improved the po-sition of women by putting them on the same legal basis with male revolution-ists."

Women are now tried by drumhead court-martial and shot down within

twenty-four hours. While denouncing in the bitterest of terms such treatment of revolutionist in general, and of women, in particular, the papers say, nevertheless, that the shooting down of women openly is far better and more humans than leaving them at the mere, of drunken Cossacks who are worse than saveges and beasts.

persons who were unknown to them had spoken about the case in the corridors of the building. Every ef-fort is being made to prevent jurors or talesmen from being placed in any position where they may be subjected to influence that would affect their verdict. A rumor was current today that

\$100,000 would be paid to any men succeeding in getting on the jury and hanging it up in the event of eleven jurors standing out for con-viction of murder in the first degree.

The sudden dropping of two men from the jury box yesterday is still unexplained. Harold Faire, one of the jurors who was dropped, says that he will insist on an explanation. Thaw is Pleased Thaw lost a good juror in Faire. He said that if the defense has put in any evidence of Thaw's insanity or showed that there was a doubt of the young man's soundness of mind he would have acquitted him of the shooting of Stanford White.

RUSS FAKE TO DECEIVE AMERICAN BANKERS

Election Returns Made to Appear as Favoring Czar, so Money Will Not Be Scared

St. Petersburg, Jan. 30.—One of the reatest frauds to which the Russian government resorts in order to deceive foreign bankers is the printing of false election returns for the Duma in its official and semi-official papers The election returns fro

three provinces printed by these papers show that out of 1,231 electors, the government party received 500; the constitutional party 458, the constitutional democratic party 35, and the two Socialist parties 238 electors. Liberal leaders claim that the figure

are incorrect, and that the Socialist and the other constitutional parties received more votes than they are credited with.

They claim that the government prints these false returns in order to give European and American bankers

ropean and American bankers the impression that the government party is stronger than the anti-government parties, and thereby hopes to re-establish its credit with these bankers.

The election returns for St. Petersburg show that 138 candidates were elected in all. Of these thirty-four were elected by the Social Democrats, eleven by the Socialist revolutionists and seventy-seven from theother radical parties, the government party having received only sixteen electors. Out of the 192 electors for Moscow, fifty-two are Social Democrats, 3 Socialist revolutionists, twenty-five constitutional democrats ists, twenty-five constitutional democrats and ninety-seven are of the conservative

ENGLAND AND SPAIN MAY BE RUINED

Gulf Stream, Which Warms Their Shores, Thrown Out of Gear by Earthquake

[Scripps-McRas Press Association.] New Orleans, La., Jan. 30.—Startling deflections in the gulf stream and strange phenomena existing in the Mexican gulf, believed to be result of the Kingston earthquake, are revealed in an official report from Cap tain John C. Soley, of the gulf division of the hydrographic office.

The stream has moved many miles to west, now passing close to of Central America in one big circle, turning to north and east, instead of keeping the sinuous line it formerly

Before the quake the gulf stream ran close to the western end of Cuba, curving and winding its way toward the American coast from the south, then turning away to the cast and resing out around the Florida peninsula to the northern waters along the Atlantic

This change in the course of the gulf stream may be productive of great climatic changes, both in Europe and the United States. Should its course continue to deflect toward the west, the balmy elimate of Spain may be trans-ferred to the eastern part of our country. New England may experience the salubrious climate of England, and Eng-land, who has owned her warmth en-tirely to the gulf stream, may be pushed into the rigorous winters of Labrador. The significance of such a change in-dustrially would be tremendous.

EDUCATION AND THE WORKERS

By MAY WOOD SIMONS

Less than five years' schooling for each inhabitant of the United States! What does this statement of the United States Commissioner of Labor mean? We know that many spend from sixteen to twenty years in study. Many others can attend school but two or three years. These latter belong to the laboring class. Add to this the fact that the children of the laborers are frequently underfed, ill-clothed and overworked during this short time and it is not hard to see that small, pitiably small, is the amount of knowledge gained by the working class.

Under these conditions their acquirements must be practically limited to the ability to read, write and a slight knowledge of numbers. The power to think, organize, arrange and invent is not only not given, but what original powers they might have had in these directions is being destroyed by the purely mechanical nature of their instruction today.

Not only must children enter the labor world before they have the beginnings of an education, but during the time they are supposed to be in school they are unable to attend more than half the time from lack of school accommodations and because a large part of them must work to support the family.

A great social change is near. Teachers and educators know that along with this social change will go an educational revolution.

The new education can only find a full development under new social conditions. The beginnings of this new education are with us, but it is being perverted today to further the ends of a decaying social

Education should mean the development of hand and brain together. It should mean that men and women will become perfectly developed beings physically, morally and mentally. But the commercial spirit of the times seizes upon but a half of this educational idea and tries instead to turn out trained human producing machines only.

What is the object of the great trade school of today? Is it not simply to produce trained engineers, architects, machinists? Trained workmen crowd each other's heels until their wages are forced down to the level of the unskilled laborer.

For fifty years the Socialists have had an educational platform. Some of the best things in the so called new education have been taken from the works of Marx, Engels and Robert Owen.

Socialists demand that the school buildings should be removed from the crowded city to the open country and surrounded with fields and workshops where the child will learn the nature of things by actual contact with them

'The crowded school room with the overworked, underpaid, teacher must disappear and no teacher work with more than ten or twelve pupils.

Today ninety-seven out of every one hundred children who are enrolled in the primary grades fail to enter the high school. The benefits of a properly arranged high school course must be made possible for every child.

The public schools are today used as a tool by the ruling class. Our children are taught those things that will help to perpetuate the present capitalistic society. What we demand is more education and of a better quality and that the children be taught the truths of history, science, art and literature, and not the biased conclusions of a dominant class.

Socialism demands an opportunity for the children of the laboring class to receive all the advantages of schooling accorded to children of any other class. It has not failed to see that our school system benefits materially but a small class in society. Class education, one thing for the laborer's child, another for the capitalist's child, that one may take his place as a wage worker and the other as a parasitic idler, these are the marks of our education today.

The time demands men and women of the working class who, putting themselves in touch with the new education, will turn it to the benefit

OBJECTIONS TO SOCIALISTS

An invitation was recently sent forth by the Daily Socialist for the expression by our opponents of "Objections to Socialism." Since that department is nowclosed, allow me to suggest that you invite the expression of objections to Socialists, and I will set the scheme in motion by airing a few of mine.

Old Age Pensions

Among the many schemes of "social welfare" that have been evolved by the employing class to stifle the complaints of their employes few have received greater favor than that of granting pensions for long and faithful service.

The last bulletin of the Massachusetts Labor Bureau gives a list of some twenty railroads that have adopted such pension systems.

The Standard Oil Company and the United States Steel Corpor tion and numerous other great combinations of capital pursue a sim

The theory upon which these pension schemes are explained to public by the professional philanthropists who are hired to superit them is that they represent the assumption by the employer of the but of caring for their aged and sick employes. These plans are commonly offered as examples of a growing soli-

darity of capitalists and employes and a living refutation of the Socialist theory of the class struggle. Even if these pension systems were all that they are claimed to be, they would have no bearing on this question. The fact that many of

the owners of chattel slaves were kind to their human possessions and cared for them in old age proved little as to the desirability of chattel slavery, and certainly did not disprove the existence of that slavery; But the pension systems of the wage-slave owner reflect again the character of the class that manages them. It was too much to expect that the capitalist should not show his bargaining, tricky nature in this

him to survive and become the successful capitalist. The more these systems are examined the more they are seen to be but clever means of fastening the shackels more firmly upon the wrists of the wage-workers.

respect as in all others. It is these characteristics which have enabled

In the first place the man who has held ever before him the hope of a pension as a reward for years of faithful, uncomplaining profit-producing is much less apt to revolt under oppression. He can be driven harder. squeezed closer, exploited more thoroughly than if he did not have this bait dargling before his eyes.

It constitutes a whip that can be made to bite deeper and sting harder than any ever wielded by the chattel slave driver of former days.

So it is that the amount of the pension is generally at once made back in the increased tension to which the worker is driven.

But this is only the beginning. A careful examination of the actual facts in a large number of industries where the pension system prevails shows that there is a most remarkable tendency to discover reasons for discharge (with of course forfeiture of the pension) as the employes approach the pension age.

This paper has recently published a number of instances of such action on the Illinois Central Railroad, and as a result of that fact, it may be incidentally mentioned that the Daily Socialist was at once debarred from the Illinois Central property, although all other papers are freely admitted.

As old age grows upon the worker his eyes grow less sharp, his feet less sure, his limbs less active. A horde of spotters are ever on the alert to catch him slipping, and little derelictions that might have been overlooked when there was still the possibility of long years of profit-producing before him are quickly counted against him when there is a possibility of his soon demanding a pension.

No system of society but capitalism could have devised so fiendishly cruel a scheme as this, by which for a lifetime a man is made to suffer uncomplaining servitude in the hope of a pension in his old age, only to discover that the very overwork which he has endured to secure that reward has been the means of enabling his master to withdraw it.

How Wealth Is Distributed

In the exploitation of our natural resources, in the production of material wealth, we have reached a high degree of efficiency. But have we kept pace with it in the distribution of wealth? Have we as nearly solved the problem of the distribution of wealth-from its nature the more difficult problem-as we have solved the problem of the production of wealth? It would seem not. A recent writer says that our national wealth is 166 billion dollars. There are eighteen million families, or an average of national wealth of \$6,000 per family. But 200,000 families own fifty billions of the 106 billions; 2,000,-000 other families own thirty billion more; of the remaining sixteen million families one-half on the average are worth between two and three th dollars per family, while the other half own less than \$500 each. Of the total national income, one-half goes to one-tenth of the people; the other half is divided among the remaining nine-tenths. Of the total national wealth more than eighty-eight per cent is owned by less than one per cent of the population, leaving but twelve per cent of the wealth for the remaining nine ty-nine per cent of the people.
