## HEAR DEBS Send Flowers and Letter Yale Town Scene of Great Shearn Tries to Force En-Socialist Demonstration.

NEW HAVEN, Conn., Oct. 9.—The County biggest Socialist rally in the New England tour of the "Red Special" took place last night when Eugene V. Debs spoke to two thousand people in the Magistrate Steinert-Strikers Are Grand Opera House and thousands of others struggled in vain to obtain admission. Debs delivered a message which was intended especially for Yale students.

"Make an early and honorable mark in life by espousing an unpopular but a righteous cause—Socialism," he told

There were a number of college men in a monster parade, led by three bands, which traversed streets illumi-nated with red fire. More than three thousand marchers participated, and times as large as the one held recently in a Democratic rally here. their task correct ideas on economic and governmental subjects: Wrong ideas can rule for a while. but they cannot rule always. No col-lege education is worth while that does not teach men to do right. This American colleges do not do not right that in a land of plenty most men should be poor, and that the poor should be those whose labor makes plenty. Thoughtful men have in the last seventy-five years invented and perfected machinery with which can be produced more than can be consumed. You students know that this ample product is not now satisfying the needs of anyone.

"I have said that this system satis fies no one. The so-called successful men are not happy. Most of you will become members of the class, using your fine minds for wages. You may think you are eco-nomically different from the brickwages. nomically different from the brick-layer, trainmen and others, but you will not be different. We want you to go to the library and study Socialism. If you do you will be one of us and certainly be of conspicuous use to your fellow men."

The Retail Clerks' Internatingal Protective Association has just started a movement for the betterment of the Giants Lay Down to Tune wage conditions among women clerks of America. This step was taken in line with the purpose officially outlined at the last annual meeting of that organization.

Many prominent women have interested themselves in this movement Helen Keller, blind and deaf, voiced her opinion of the subject in no unertain note. She said:

"I am greatly interested good work which the Retail Clerks' Protective Association has under-taken, and I shall be delighted to do whatever I can towards promoting it. I have always felt warm sympathy for young women and children in shops, and often expressed my earnest desire that something be done for them. I have tried to realize how they begin life's battle full of hope and determination to do well and live rightly. My heart has ached at the thought of how they must face unfair conditions which are almost certain to thwart their efforts and unequal that the ambitious young woman loses heart and bends her neck to the yoke of sin. I rejoice that movement in behalf of those women association will not cease its efforts until every woman who tolls for her bread shall receive a living wage, and be protected from the poverty which enalayes."

The first literature of this movenent is being sent to every employer of women clerks in America. is being issued by the Women's Auxiliary, acting under the auspices of the Retail Clerks' International Pro tective Association. Other literature will follow, and as soon as the political campaign is over some of the women speakers and organizers of America will tour the country in the interests of this movement.




