Ministers Criticised for Rebuking Strikers While Saying Nothing to Besses. Long Hours and Terrible Accidents.

The social service commission of the deral council of the Churches of Christ in America has just made its report on what it terms the "deplorable social and economic conditions of the men employed in the Bethle-

Just before the strike, the report Just before the strike, the report continues, 4.725 men. or 51 per cent of all the employes, worked twelve hours a day; 220 workmen had a twelve-hour day except on Saturdays, and 4.203 employes had a work day of ten and a half to eleven hours in length, generally with a half day off on Saturday. "The situation with regard to Sunday work in Bethlehem." the committee avers, "is worse that that found in the Pittsburg steel mills, as discovered by the Pittsburg survey."

With regard to wages, the committee declares that (i) per cent of the 9,184 employes earned less than 18 cents an hour, or \$2.16 for a twelve-hour day; and 31.5 per cent estred less than 14 cents an hour, or less than \$1.68 for a twelve-hour day. Mexican Soldiers Hold Down Attempts State Department Sure American of Anti-Reelectionists to Dethrone Barbarous Czar.

EL PASO, Tex., June 26.-It may very light vote is said to have been polled in the election for presidential and vice presidential electors. Troops were in evidence in considerable numbers at all of the polling places, and crowds were not tolerated.

> The proposed railway system has a total of about 2,000 kilometers or 1,200 miles in length, and involves an estimated expenditure of about \$100,-000,000. The main line will run from Suediap, a port on the Mediterranean city of Diarbekz, and thence to Bitla and Van. The company has asked no subsidy or guaran tee from the Turkish government, except the exclusive right to work the mineral deposits along the line. It has not been revealed what group of American financiers are back of the enterprise

> The German ambassader at Constantinople has protested against the granting of the concession on the ground that it conflicts with the rights and privileges granted to the German group holding concessions for the Bagdad railroad, and that it is also in conflict with the Turkish mining law of 1907, which was passed at the time the powers consented to an increase of from 8 to 11 per cent in the Turkish customs duties.

> It is understood, however, that the legal advisers of both the Ottoman government and of the American company have reported that the position of the German government is unten-able, and that the proposed concession in no way conflicts with either the Bagdad concession or with the Turkish mining law. Several weeks ago Secretary of State Knox, who is lending diplomatic support to the American enterprise, began direct negotiations with the German government to overcome its objections. Knox suggested that the German foreign office reinvestigate the matter.

# THREE SHOT DOWN IN CHINESE FEUD

### Innocent Sing Yen and Two of Four Brothers Hit by Leaden

Fusillade.

Big Bill Hodgins, captain of police in Chinatown, stood yesterday afternoon a little before 4 o'clock in the deerway of Jimmy Naughton's livery STREBEL FOR LIEUT. COVE stable in Mott street, just above the ooked east along Pell street and vawned.

Sightseers were scrambling for outlets, any way to get them out of the furious turmoil.

There have been more strikes in more trades involving a greater number of persons among non-union workers employed in so-called open shops than among union artisans. union artisans.

## POOR OF VIENNA

Attempt to Relieve Scourge of Poverty in City's Crowded Slun

In no other capital in Europe ha the cost of living increased so greatly during the last two or three years as in Vienna, and parliament has taken one step toward easing the strain by grant of money for the building of cheaper dwellings. Fifty thousand pounds a year for ten years will be placed at the disposition of local aubuilding associations thorities and with this object.

The amount is not very large to ward the improvement of the housing of the poor, who suffer terribly at present from overcrowding, says the London Pall Mall Gazette. According to the last statistics available nearly one-half of the apartments in Vienna which are all flats, consist of only one room, sometimes with a kitchen, but mostly without. Forty-three per cent of the whole population are living in these one-room flats, and that is not the worst, for not fewer than 30,000 of these miserably small dwellings are occupied by six or more persons.

## LET MACHINERY 'DO' YOUR DISHES NOW

Profit Seekers Demonstrate Sannaness of One Socialist Argument.

The company will provide each family with two boxes, one for china and silver ware and one for pots and pans. boxes will bear the number of apartment and will fit the dumbwaiter. Polite employes, in uniform, will call for the disher went by with a transfer in his hand after each meal, send them down the dumbwaiter, wash and return them in a few minutes. An interesting feature of this plan is that the company agrees to pay for all breakage. The employes are paid a bonus of \$2 a week if they do not break or lose a dish and are docked if they do, unfortunately.

"As every woman knows," says the ctus. "there is always a time when one is without a maid. Every one hate to wash dishes, but some one has to do it at some time. We will take all that ouble off your hands. Your dishes wil be kept entirely separate, so there will be no fear that they wil get mixed with others. Every dish will be thoroughly sterilized and your pots and scoured.'

## OPENING THE STATE CAMPAIGN

State Secretary Solomon was able to report that the finances of the state organization are in excellent condition, and the convention to which he reported was one of the best, most enthusiastic and vigorous ever held in New York. The two facts indicate a stirring, spirited and intelligent campaign. This year, beside members of the House of Representatives, a governor, state senators and assemblymen will be elected. For all these offices the Socialist party will have men in the field. It is an election of the utmost importance and significance. Old party lines have been broken to a marked extent. There has been dissatisfaction with the national government and recent disclosures show the government of New York state is foul with corruption. Both the old parties, to save themselves, have begun to raise the cry of "Turn the rascals out." But there will be and can be no effective turning out of the rascals unless it is done by the Socialists. A Socialist victory would mean turning out the rascals, and the institution of measures to end the conditions that place a premium on rascality.

Consequently, to make the nominations at Schenectady more than a mere formality, our campaign should swing into full life and activity at once. It should be state-wide and the principles of Socialism should be made known to every dweller within the state. While such a campaign is shaped by the fact that we are werking for the nominees on the ticket, it has another and broader ance. It is an opportunity to build up the party organiza tion. Every meeting, rally and page of literature has that object and the more meetings effectively held and sound literature distributed, the more it will assist in the development of the party.

This campaign of 1910 should mark the beginning of a Socialist

that is a power in the nation. It can be made so only through hard, intelligent work, and now that an excellent state ticket is in the field, and as it will soon be followed by Congressional and other nominations, every Socialist has his task allotted him. ## THE BUREAU OF MINES

President Taft looks upon the creation of the bureau of mines and the appropriation of \$502,000 for its use as one of the great ac-complishments of his administration. Theoretically the bureau should be of enormous value. The slaughter in the mines has grown steadily and practically nothing has been done to stop it. Most of the accidents are avoidable, but the companies find it more profitable to take the risk, kill a few thousand workingen and maim a few thousand more, than to do anything toward safeguarding the mines.

The new bureau will have this matter of safeguarding the miners

mong its other responsibilities. If it lives up to its duty this pholesale murder will cease. If it lives up to its duty, also, the bureau of mines will instantly find practically all the operators in opposition. The operators are content with affairs as they are. They may deplore the slaughter and they may feel sorry for the families of the murdered miners, but it would cost money to prevent the accidents that cause the murders.

But the hope that the new bureau will be efficient is a re one. So far every department of the government devotes all its energies toward promoting the interests of the capitalist class, and it is more than probable the bureau of mines will follow this worthy
