### Speech at German Party Congress for Loyally and Solidarity.

MADGEBURG, Germany, Sept. 20. -A heated debate took place at today's session of the annual congress of the Social Democratic party over the action of the Socialists in the Grand Duchy of Baden in supporting

the government and in voting for the

budget. August Beliel opened the debate with a scathing attack on the weakness of the South German Socialists thus compromising with the Grand Ducal government." He characterized the actions of the Baden Socialists as traitorous and firmly withstood a violent attempt of his opponents to shut him down.

Bebel's whole speech was a possion ate plea for adherence to the undiluted revolutionary principles which he decaired to be the foundation of the Socialist movement.

During the course of his speech Bebel declared that Bismarck, the iron chancellor, admitted that the present social policy of Germany was due to the Social Democratic party. This concession of social reforms was only obtained, Bebel argued, through perfect union of the party forces.

#### Allliances Scorned,

With withering sarcasm Bebe scorned the idea of forming a parliamentary bloc with the National Liberal leader in the reichstag and saying jeeringly to him:

"Well, blocabrother, how do w Basserman retorted: "Why, non

ense! Utter nonsense!" And Bebel raplied: "My view ex-

Once Prussian electoral reform is sined Bebel praued, the Socialist will be on the high road to gain all He pleaded for complete unity of party forces and advised the Social ists to refrain from alliances with any other party in the reichstag.

Bebel concluded his eloquent address with a plea to the Social Demo rats of all parts of Germany to march forward shoulder to shoulder in the face of every obstacle.

His position with regard to voting for budgets of the various kingdoms states and principalities, is in perfec accord with the decisions of previous congresses of the Social Democratic The Baden Socialists. how party. ever, have voted for the budget on opportunistic grounds.

# BAKER UNFIT, **GAYNOR AGREES**

Suspension of Head of Police Department is Postponed Until Mayor Returns.

#### MITCHEL FAVORS HIS REMOVAL

Commissioner May Have to Face Indiciment as Result of Grand Jury Probe.

Police Commissioner Baker is to be deposed for insubordination, of that there can be no doubt after reading Acting Mayor Mitchel's statement yesterday, following his conference with Mayor Gaynor, at St. James, L. I., the night before. This prediction was made exclusively in The Call lust Sunday. Baker's official career as head of the Police Department is already virtually ended.

Yesterday morning the further prediction was made in these columns that Baker's official head would be lopped off during the course of the day, and that prediction would have been fulfilled if Acting Mayor Mitchel had carried out his own wishes but out of courtesy to Mayor Gaynor, who expects to return to his duties at the City Hall during the course of the next few days, action in the Baker case has been deferred until Gaynor' return.

Baker relied upon Gaynor to uphol him in his conduct of the Police De partment, but, according to Mitchel's statement, that hope has no basis, i fact. Gaynor agrees with Mitchel.

#### Mitchel's Statement.

The finish of the Baker come after Gaynor returns to his desi at the City Hall in a few days, accord ing to Mitchel. Gaynor will, himself act as headsman when the job is done Acting Mayor Mitchel gave out the following statement to the press yes terday:

I saw Mayor Gaynor at St. James last night, and laid before him the entire police situation, including Commissioner Baker's letter to me of September 17.

The Mayor requested me not to make this letter public, and to leave the police matter in abeyance until his return, which, he promises, will take place within a ew days

"Is that all?" asked a reporter. "That is my statement," said th

## PATHETIC ARMY PACKS ARMOR

Six Hundred Bables Undergo Examination by Doctors of New York Nursery and Child's Hospital.

Pitty pat, patter!

An army of little victims of capialism gathered in the 12th Regiment Armory, at Columbus avenue and 62d street, yesterday, for physical examination. There were 600 kids in that army, and their ages ranged from a few weeks to six years. They were of all kinds, sizes and conditionssome of them twins.

This army of tiny boys and girls are children of parents who are dead, too poor, or too busy grubbing for ah existence to care for them. They are "boarders-out," known as been intrusted to the care of the New York Nursery and Childs' Hospital which sends them into homes of persons willing to board them for \$10 or \$12 a month.

Twice a year the hospital calls all of the children boarding out and submits them to a physical examina tion in order that the hospital physicians may have an opportunity to ob serve the condition of the youngsters.

#### Children Watt in Line.

From Long Island, Staten Island, Jersey City, the Bronx, and all parts of Manhattan, came this army of kids bringing their "mothers" The doctors and nurses had their hands full handling the equirming. cared youngsters.

Three brawny cops were on duty as the youngsters poured into the Armory, but they had little to do, for, as one of them expressed it, when it comes to taking care of a crowd of kids, women are most scucessful."

When the doors of the Armor:

were thrown open yesterday morning tong line of women and children stretched away along the sidewalks. some carrying that fittle of phant in their arms, some pushing baby carts ome placating tearful, frightened babies and others leading pale lads and lasses of four and five.

Hospital physicians carefully exmine the children, noting whether they are fat or thin, examine their tongues and eyes and search their throats for adenoids. Careful record is made of the condition of these walfs, and when they are six years of age if their parents are dead or have been forced by poverty to give then up forever, an effort to find foster parents is made.



PHILADELPHIA Sent. 20 .- Sus pender Makers' Union No. 10342. Local Philadelphia, at a special meeting held Saturday evening, went or record as being opposed to the newly reated United Labor party, recently formed by John J. Murphy, president of the Central Labor-Union, and his committee of eleven.

THE FUTILITIES OF REFORMERS.

The absolute inability of reformers to deal effectively with a single one of the innumerable problems presented by capitalist society and pressing for solution was demonstrated in a most striking

The City Club is an association of the highest respectability. Its membership consists exclusively of citizens of substance and their political or intellectual hangers-on. They are also an exceptionally mest set. Not one of them has ever been accused of picking his neighbor's pocket, although several of them are known to have no in-

perable aversion to franchise grabbing and similar profitable but

But this is a funny world, and the City Club is here to furnish ne of the fun. All summer the City Club was out of town, seeking health and refreshment in the cooling breezes of mountain and sea. And now that life in the city has again become endurable the City Club has come back to town and is wrestling again with the old, old problem of the city streets and the public service corporations.

It is a knotty problem. For many, many years past the streets of what is now New York city have been granted away by the state legislature and by the officials of at least forty communities which were consolidated into the present city. These franchises have been tinkered with by legislatures, attorney generals, aldermen, corporation counsels, department officials, and courts of the city and state. In the rights of labor in social and inmany cases corruptly, in all cases favorably to the corporations, so

as to tighten their grip upon the public highways.

The surface and elevated railways, the electric light and power systems, and the gas works are mostly operated under grants that are claimed to be perpetual. There are still more than 400 streets and parts of streets, with a total length of 240 miles, upon which no etreet car tracks have been laid. Nevertheless these streets are claimed by the corporations under charters granted before consolidation. "Some of these franchises are known to be void," said Mr. D. F. Wilcox, chief of the bureau of franchises of the Public Service Commission, "but inconsistencies in the judicial decisions, jokers in the railroad law, the unblushing assertions of the companies, and the continued acquiescence of the public authorities tend every day to confirm claims that are utterly inexcusable in theory and unsound in law. It is a well-established rule of law that public grants of special privileges to private parties should be strictly construed in favor of the public. This rule has been almost reversed in New York."

Mr. Wilcox took the Consolidated Gas Company as a conspicuous example of a corporation with extravagant and absurd claims under ambiguous franchises. Company after company has been absorbed by this powerful corporation. It is now utterly impossible in many cases to distinguish between the properties of the various companies that have been mixed and merged in "Siamese relations," so that they have become nothing but empty names. Nevertheless the Consolidated Gas Company is now taking proceedings to build new tunnels under the East river that will be worth millions of dollars to it, because in 1892 a franchise was granted by the legislature to the ast River Gas Company of Long Island City, which was absorbed by the New York and East River Gas Company, which was consolidated with the New Amsterdam Company, which in its turn was merged with the Consolidated Gas Company.

The courts have contributed as much as any other factor toward strengthening the hold of the companies upon the city. For the courts are everywhere in this wonderful country of ours. or meeting the financial needs of the year 1911 have been under way in the departments and bureaus of this cit; of nearly five million people. Du budget is a long and complex affair; it could hardly be otherwise, consid ering the many and varied activitie of the municipality and the army of employes on the pay rolls. Departmental estimates are highly specialized work in quite another sense than the political one, though, no doubt. politics enter into their make-up often enough

But money, and plenty of it, is needed for perfectly legitimate pur-poses in all those branches absolutely necessary to the health and moderate comfort of the city's inhabitants, to say nothing of such departments as that of education. Our streets must be kept in fair condition and be cleaned; the water supply must be of contagion; we must have police and firemen to protect property and life, to put the two items in their accepted capitalist order. Worked out in detail the list is rather a long one

The amount appropriated for th "expense of conducting the public business of the city" during 1910 was \$153,775,145.53. In addition over five millions were appropriated for the expenses of the counties of New York Wing Owens and Richmond. York, Kings, Queens and Richn York, Kings, Queens and Richmond, and four millions more for the deficiency January, 1909, in the income from taxes. It is a budget larger than that of some kingdoms. It includes interest on the city debt and items coming under the heading "Re-dempion of the City Debt," as well as current expenses of the municipal deparments. But persons conver-sant with municipal financial affairs say that it reveals little of the city's actual financial condition in that it does no deal with the bonds outstand-hor does it give any idea of the municipality's enormous assets in real estate, water works, docks and fer-

ries, etc.

To date this year the departmental estimates are still in the preliminary stage. Only the foundation for next year's budget is being laid. The work of getting the whole thing into shape will come a little later.

For the sake of clearness it will perhaps be well to quote direct from the Greater New York charter, section 246, legal verbiage and all:

The said board (of estimate and apportionment) shall annually, between the first day of October and the first day of Nevember, meet and make a budget of the amounts estimated to be required to pay the exness of the City of New York, as constituted by this act, and of the counties of New York, Kings, Queens and Richmond for the then next ensuing year. Such budget shall be prepared in such detail as to the titles of appropriations; the teerms and conditions, not inconsistent with law, under which the same may be expended; the oggregate sum and the items thereof allowed to each department, bureau, office, board or commission, as the said board of estimate and apportionment shall deem idvisable. In order to enable such oard to make such a budget, the presidents of the several boros, the teads of departments, bureaus, offices coards and commissions shall, no ater than September 10, send to the beard of estimate and apportionment in estimate in writing, herein called a departmental estimate of the amount of expenditure, specifying in Jetail the object thereof, required in their respective departments, bu-reaus, offices, boards and commis-

their respective departments, bu-reaus, offices, boards and commis-sions, including a statement of each of the salaries of their officers, clerks, employes and subordinates. employes and subordinates. Dupli-cates of these departmental estimates and statements shall be sent at the same time to the board of aldermen. Before finally determining upon the budget the board of estimate and apime or times as may be necessary to allow the taxpayers of said city to be heard in regard thereto, and the said board shall attend at the time or times appointed for said hearing. After such budget is made by the board of estimate and apportionment it shall be submitted by said board within five days to the board of aldermen, whereupon a special meeting of the board of aldermen shall be called by the mayor to consider said budget, and the same shall be simul-taneously published in the City Rec-ord. The consideration of such budget by the board of aldermen shall continue from day to day until final action is taken thereon, but such consideration shall not continue beyond twenty days, and in the event of said board of aldermen taking no action thereon within such a period of time the 'said budget shall be deemed to be, finally adopted as submitted by the board of estimate and apportionment. The board of aldermen may reduce the said several amounts fixed by the board of estimate and apportionment, except such amounts as get by the board of aldermen shall reduce the said several amounts fixed by the board of estimate and apportionment, except such amounts as are now or may be hereafter fixed by law, and except such amounts as may be inserted by said board of estimate and apportionment for the payment of state taxes and payment of interest and principal on the city debt, but the board of sidermen may not increase such amounts nor vary the terms and conditions thereof, mot insert any new items. Such action of the board of aldermen as reducing any item or amount fixed by the board of estimate and apportionment shall be subject to the veto power of the mayor, as elsewhere provided in this act, and unless such vote of the board of aldermen the item or amount as fixed by the board of estimate and apportionment shall stand as part of the budget.
