### LIEBKNECHT MAKES 2 SPEACHES IN NIGHT

Brilliant German Socialist Greeted by Great Throngs in Brooklyn and at Lipzin Theaetre.

The thousand of people who packed the Brooklyn Labor Lyceum to overflow last night, to hear Dr. Karl Liebknecht, carried with them a vision which will linger in their minds to the end of their days, and a lesson which will bear fruit to the Socialist movement in America in the near, one might almost say immediate, future. Liebknecht's address last night was a sort of a cursory report of what the working class of Germany and of Europe was doing for the liberation and regeneration of the world. Together with this report went the advice of the expert general and leader, who has been born and raised in the atmosphere of revolution and international Socialism, as to what the workers of America should do to make the international onslaught on capitalism most effective. nost effective

Workers of World Uniting.

Workers of World Uniting.

Liebknecht informed his audience that the day of nationalism is gone so far as the working class is concerned. Today, he said, workers are no longer divided, according to nation or language. Workers of all lands are soldiers of a great international army which is marching under the banner of Socialism.

In the first part of his speech, Liebknecht went into a detailed description of the reaction in Prussia. He pointed to the almost daily conflicts between peaceful citizens and police officers who are armed to the teeth, and seek to prevent the workers from giving the least expression to their feelings and views.

From the political reaction the speaker next went over the social and conomic reaction, or rather progress of capitalist oppression. He showed how capitalism while prating of nationalism and patriotism knows of no nationalities, of no patriotic ties when the question of dellars and cents comes.

Krupp's Patriotism.

'Krupp,' Liebknecht cried, 'is a German patriot. The managers or owners of the Krupp gun works are all considered among the best and most patriotic types of Germans. Yet the same company will sell guns, cannons, and any and all ammunition to England, to America. Yes, even to France, the supposedly bitterest enemy of the German fatherland and German people. To France they sell the most modern of machine guns with which to kill the German people in case of war. This is capitalist patriotism for you.

"In this morning's paper I see that a certain Mr. Taft, a brother of your president, who came on the same ship with me expressed himself as very much pleased with Prussia. ### EVALENKO "GUILTY" SPAIN IN DREAD SAYS COMMITTEE

He was a mem-ber of the Russian Social Democrats, the Bund, the Socialist Revolutionist organization, the Russian Students' Club and many other Russian organi-zations, the statement of the com-mittee declares.

sensation on the East Side at the
time, Evalenko was for years a publisher of Socialist literature, and well

known in radical circles.

MADRID, via Hendaye, France, Oct.

11.—The Spanish government has completed elaborate precautions to put down a possible armed revolt next Thursday, the anniversary of the execution of Professor Ferrer, director of the Modern School of tlarcelona.

There is a growing belief, however, the Republican leaders will not select that day as the time for an insurrection against the rule of Alfonso. The government is so strongly intrenched that unless the army can be relied upon to join the revolutionists an outbreak would be sure to be crushed with great bloodshed.

When the Portuguese Republic ordered the expulsion of all the Portuguese name and monks, Spain immediately decided that none of them might enter Spanish convents or monasteries. By this decision he makes the woman Socialist the opponent for the office he holds.

This decision puts an end to the cry which has been raised by the opponents of the Socialist party that a woman cannot legally run for state office in Connecticut. Mrs. Bloor is now preparing for a vinorous campaign.

Mrs. Bloor was nominated for secretary of state on the Socialist ticket some time ago. Recently her nomination was confirmed by the referendum. The question of the legality of naming a woman for the state office was constantly being raised until the secretary of state, upon whose office devolves the duty of determining the law in such cases, took up the matter. After an exhaustive investigation it was found that under the law and under the constitution the nomination of Mrs. Bloor was legal.

Great Northern Railway Complete ly Tied up by Revolt of **Poorly Paid Slaves** 

ARE REASONABLE

PARIS, Oct. 12 .- At one o'clock this norning the National Confede of Railway Unions voted in favor of a general strike on all the railway systems. Instructions were given that the vote should be made effective mmediately.

The employes of the Western Rallway have joined the strike. This means the stoppage of all communication, except by automobile, between Paris and the ports in northern France.



LITTLETON, N. H., Oct 11 .- The Saranac Glove Company has locked out nine for belonging to a trade union, although they have made no demands. Two weeks ago the employes of the Saranac company organized into a local of the Glove Workers' union, and the moment the mpany learned of it three men were lied to the office and asked why called to the office and asked why they had formed a union. The men told the officials of the

company that they believed that they had a perfect right to belong to a union if they felt so disposed. The entire board of directors took turns telling the men what they thought. Finally the men were told point blank that they could not have a union. that they would employ no union men in their factory.

The directors argued that they did not want any guard.ans over their business. They said that the union will make trouble.

The workers reminded them that the union had asked for nothing, to which the directors replied: "We want you to get done with it at once; give up the union." This occurred in the morning. In a few minutes the boss came around and demanded that the men make out work tags. One workman did not comply with the request quick enough to suit the foreman, and he said to him, "the superintendent says you will draw no pay after noon."

"No general epidemics occurred furing the year, and the mortality rate was lower than that of any previous year for twenty years, except 1998-93. The number of deaths per thousand was 22.10, and compares favorably with other countries. The rapid decrease in the mortality rate may be considered remarkable when it is noted that from 1888 to 1898 there was an average death rate of thirty per thousand, and that in 1991 it had increased to forty. The insular government authorities co-operated with the municipal officials in checking and wiping out several local epidemics, in connection with which 26,338 persons were vaccinated. A rigid inspection has been maintained for the purpose of safe-guarding the food supply. In this connection, \$4,-250 animals were inspected before slaughter and an active campaign was conducted against false labels and misbranding. This mode of issuing summonses treats it as a document of importance, and not to be issued rashly or indiscriminately. The same policy was pursued with regard to those summonses entrusted to the police. Every policeman in Greater New York now carries a book resembling a check book. The sumnons in that case has two stubs at tached to it. One he returns to the station house, through which it goes to the court, and the other he keep

in his book to protect himself. You will also, I have no doubt, be gratified to know that the summons, new made legal by the new law, is to a great extent superseding warrants, much lessened.
