Japanese ambassador at Washington to insist upon a retrial of the case of Genkyo Mitsunaga, the subject of the mikado

insist upon a retrial of the case of Genity of Mitsunaga, the subject of the mikado convicted late last night of murdering Mrs. Katherine Wilson last May by straugling her with a piece of cloth and then stuffing her corpse into a box. The verdict was murder in the first degree, the jury fixing the sentence as imprisonment for life.

Mitsunaga, who was the only Japanese in the courtroom when the verdict was read, maintained the remarkable self-control which has characterized his demeanor throughout the trial. He did not show the slightest emotion and did not indicate by even the blinking of an eye that the jury's finding startled him. He was taken back to jail to await formal rentence, and today declined to comment on the verdict.

Dr. Bennett did not say what course he would pursue, except that he was determined that Mitsunaga should get absolute justice. The interest shown by the Japanese government and Mitsunaga's fellow countrymen is intense, however, and it is not likely that they will let the case rest where it is. The mikado's government has asked its representatives both here and in Washington to insist upon absolute impartiality and to see that to American court permits race prejudice to enter into the verdict.







The last convention of the American Section of Labor was in many respects a tiresome and sleepy affair—with its numerous jurisdiction squables that had been settled before, settled again and yet never can be settled, as long as the present structure of unionism in America remains as that—in places where the working to is.

But on this very point the last convention proved to be almost revolutionary. It practically decided to abandon trades autonomy. This convention payed the way for a new country.
