Citizens Alliance Cut-Throats Threaten Violence-Let Them Try It!

Every contemptible and malicious trick known to union-busting employers has already been employed to disrupt and smash Drivers Local 574. The sewers of misragesentation, falsehood and slander have been opened up and spewed against our organization. Thousands of dollars have been spent in employers' publicity against the Union in the press they control. Not only in the "respectable" papers, but in the weekly scandal rag which pollutes the atmosphere, the truckers and their leaders have been subjected to a running fire from the very beginning of the dispute.

But all these battering rams of the employers have been unavailing against the powerful structure of our Union, held together by the solidarity of its members, by their contempt for backbiters and windjammers, by their determination to let nothing stand in the way of their righteous fight to gain conditions that will permit them to live like human beings.

The employers said that the Union does not represent the men. Thereby they provoked the two strikes-in May and the present one—in which the thousands who responded to the strike call gave conclusive proof that the Union DID represent the men.

The employers then tried to disrupt the Union from within, by the efforts of concealed agents or unconscious tools. They claimed that the majority of the men did not support the policy or leadership of the Union. They organized separate meetings to plan the dis-ruption of the Union. Thereupon, the vast bulk of the membership rose to demonstrate its unanimity and to reveal that the disrupters represented an insignificant handful of uninfluential individuals. The meetings of the demoralizers were turned into magnificent demonstrations for the Union.

The employers tried to drive a wedge between the rank and file and the leaders. They wanted these leaders out because they couldn't bribe them or frighten them. They launched a vicious "red scare" campaign against the leaders of 574, under the impression that the union members were four-year-old children who could be scared with a bogeyman. Thereupon, the membership replied by giving their officers a unanimous vote of confidence.

The employers finally tried the claim that the members really didn't want to strike, that they were really anxious to accept the miserable terms of the bosses. Thereupon, the membership replied on two occasions with a rousing, enthusiastic and determined unanimous vote FOR the strike which was launched Monday midnight.

And they did strike. And what is more, they have succeeded in bottling up the market so firmly that not a single truck has been able

In their desperation, the employers are now playing their last card. It is a despicable one, smelling of the swamp out of which it comes. It raises the "red scare" to a new pitch and calls upon the "respectable citizens" (How well we know them!) to lynch the leaders of Fighting 574.

'The Communists have overreached themselves in San Francisco, though they succeeded in dragging organized labor into their conspiracy, and for a brief time in effecting a nearly complete tie-up. The citizenry, harking back to the traditions of the Vigilantes of the Fifties, set about stamping out the Communist hangouts and their equipment for issuing revolutionary literature, and running the Reds themselves out of town.

The Communists in Minneapolis have thus far succeeded in keeping their control of the Truck Drivers Union, in preventing a secret ballot on the renewal of the strike. and in dominating the labor side of the controversy. BUT LET THEM BEWARE LEST AN AROUSED CITI-ZENRY HERE TAKE VIGOROUS MEASURES AGAINST THEM."

Provocative Bluff of Police Chief Only Shows How Completely Truck Traffic Is Tied Up

In an effort to provoke a bloody riot, Police Chief Johannes pulled a swindling maneuvre yesterday afternoon for the bosses, which was foiled by the speedy and disciplined action of Local 574. With a great display of armament, and in front of a battery of movie cameras and an audience of reporters, Jo-Jordan-Stevens Co., wholesale grocers, to the Eitel Hospital.

LATEST NEWS FROM THE STRIKE FROM

U. S. Strike Wave Still Rising

The militancy and the determination with which large sections of the nation's working class has downed its tools and gone to battle these last few weeks betokens deep-seated dissatisfaction over intolerable conditions of the workers, both employed and unemployed, under the so-called New Deal. Not since 1919 have so many workers been in motion as are now on

The tremendous pickets lines surrounding the Kohler plant in Wisconsin were 100 per cent effective yesterday. No one was permitted to enter the plant. Carloads of coal consigned to the power plant were turned back. Strikers, impatient at delay in mediation conferences, say they will keep right on picketing.

In Decatur, Alabama, two men be lieved to be strikers were beaten and one man was shot in the leg. The striking textile and rubber workers are standing firm.

In Portland the workers have yet to decide on the general strike. Conditions are very tense. Pickets regained one pier after having been driven away early in the day by "special guards" using gas.

In Seattle, the same: everything is tense; anything may happen.

Cleveland's striking taxicab drivers went back to work yesterday after having forced the bosses to capitulate Recognition of the union and a weekly minimum of \$12.00 were won.

As to Frisco-the general strike committee has recommended that the united action be called off; this passed by the close vote of 191 for, 174 against. Each individual union will have to ratify this recommendation by ballot of the members. The proposal to call off the general strike was bitterly opposed by the leaders of the longshoremen.

Reconciling themselves to the withdrawal of other unions from sympathetic action, blaming conservative labor leaders for mismanagement of the general strike, delegates from the maritime unions stated that their men would fight on until their demands are won.

Up to Thursday noon, 30,000 of the 100,000 workers on strike had signified their intention of going back to work. the three-day strike had cost business houses millions of dollars. Especially hard hit were the newspapers, movie houses, oil companies, department stores and banks.

shelter of just about one-half of the Minneapolis Police Department.

Thirdly, the plan was to provoke a riot so that the cops could shoot down pickets and Mayor Bainbridge and the bosses could howl for the militia to be brought out to move trucks.

Quickly recognizing the nature of the plot, the Union refused to fall in the trap. As announced by President Wm. S. Brown of Local 574 last night, however, no change in Union orders respecting hospital deliveries is to be anade. Trucks cannot move for this or any other purpose without a Union driver and this means a permit from Local 574's Strike Committee.

The names of the finks who loaded the fake cargo at Jordan-Stevens have been turned in to the Union by a J-S employee, along with the name of the scab driver of Johannes' circus car.

Vincent R. Dunne and Farrell Dobbs of Local 574, who had an appointment scheduled with Federal mediator Rev. F. J. Haas, to provide him with data as to working conditions in the Minneapolis transport industry, notified him that they would not keep their appointment as long as Johannes was sending cops on the streets to provoke strikers. Later in the day they delivered the desired information and entered a vigorous protest against the Police Chief's malicious but unsuccessful scheme.

The boss press, incidentally, unanimously reports the whole incident as a serious break in the strike front. This is an attempt to save something out of the failure of the plot. Happily, The Organizer can get the truth to the worker of Minneapolis. The picket lines are unbroken! The fight goes on! Local 574 will not be provoked by Johannes or anyone else.

No trucks are going to be moved! By nobody!

How to Get Kidded Out of Your Wages by the Boss

The Journal runs a "column" cailed Off a Reporter's Cuff" which contained an interesting item yesterday. In it is exposed exactly how through trickery the employer manipulates, exploits, pushes, forces and salves his slaves into position. I quote the Minneapolis Journal, reading you the article first and then interpreting it as any intelligent child or person would. Also proving to you conclusively what we have told you right along that it is a matter of sparring for time, vacillating, procrastinating, anything to smash the worker. It starts out with-"Don is the best salesman in that sales or ganization in the Plymouth Building.

They conceded him to be a producer, they conceded him to be a hard worker and a high class man. So much for that. To continue quoting the Journal-"That the Sales Manager is one of those high-pressure gentlemen who come barging into the office and open up the morning each day by blasting the side off everyone in the officemanager to office boy." (Haven't we preached this to you boys, day in and day out? It's nothing new, we know the bosses always take it out on the worker.) But the article continues, that this Don, this high class salesman and producer they are referring to, "has devised a system to escape the periodical tongue-lashings the rest of the force get." In that respect, Don is a little smarter, a little sharper, than the other boys in the office or on the sales force. But as I continue with the article, quoting the Journal, you endorsed by you or not.

will see where Don, too, becomes a victim of exploitation through manipulation and boss tactics.

Continuing, it quotes,-"At intervals Don strikes into the Sales Manager's

office and demands a raise in salary." Well, Don, old boy, old kid, old sock, old pal, that's one thing we give you credit for having that much guts at least. It's too bad though, as we quote the rest of the article we find how cheaply they buy you off.

"He is thereupon invited out to lunch, then for a swim to the M.A.C. (the Minneapolis Athletic Club, one of our neighbours), then for bridge at the Sales Manager's home." This entire piece of salving costs the employer about sixty cents.

He concludes this article, adding, But the psychological effect of the salary request wears off in from twelve to seventeen days, after which the treatment must be repeated." That concludes their article and its conclusion is a truthful one. It's a treatment that has been applied in various ways, and has even been tried on good old 574, but it didn't work.

All I can say for the Journal and their reporter is, Don't forget the newsboy's strike, when you hired gunmen and thugs to club the kids, when you had your tinhat soldiers pointing bayonets at kids throats and stomachs.
