There is no more sublime spectacle presented to the eyes of men than the-sympathy strike. Beside it the vaunted glories of triumphant armies pale into insignificance by comparison. For those engaging in a sympathietic strike risk their all for their fellows of the working class. They put their faith in each other and their cause, the welfare of their lowed ones and their exportunity for employment (the most precious thing they have under the present system) against the organized forces of capitalism, the forces having at their command unlimited wealth, a venal press, a craftily guided horde of corrept adventurers and disceptuable strike heakers, a distorted and prejudiced public opinion and—what is greater than all these—the powers of irril and military government, but recently voted into the hands of their enomies by the working class itself.
